The Codington County Commissioners met in regular session at 9:00 a.m., Tuesday, June 10, 2014, at the Codington County Courthouse. Commission members present were: George Heller, Tyler McElhany, Myron Johnson, Elmer Brinkman, and Brenda Hanten; Chairman Brinkman presiding.

AGENDA APPROVED

Motion by McElhany, second by Hanten, to approve the agenda, all present voted aye; motion carried.

MINUTES APPROVED

Motion by Hanten, second by Johnson, to approve the minutes of May 27, and June 5, 2014; all present voted aye; motion carried.

JAKE BRAKE ORDINANCE SECOND READING AND ADOPTION

The Board held the second reading and public hearing for a proposed ordinance to prohibit the unlawful use of engine and compression (jake) brakes. Motion by Hanten, second by Heller to adopted Ordinance #57, an ordinance to prohibit the unlawful use of engine and compression (jake) brakes. Chairman Brinkman opened the hearing to the public. Mike Lantsberger and Steve Wess spoke in favor of adoption of the ordinance. Chairman Brinkman closed the hearing to the public and turned to the Board for additional comments. Highway Supt., Rick Small and Sheriff, Toby Wishard also contributed to the discussion. Upon vote of the Board; Hanten, Brinkman, Heller, and McElhany voted aye; Johnson voted no; motion carried.

MONTHLY REPORTS

Auditor, Cindy Brugman, reported on recent election activities, 2015 budget preparation and 2014 pay 2015 property tax values. The Auditor expressed her appreciation to the the Emergency Management Office and Maintenance Office for their assistance with election set up, and delivery and pick up of election equipment. **Weed Supervisor, Steve Molengraaf and Weed Manager, Paul Johnson**, reported spraying operations are moving forward quickly due to excellent weather conditions with two Townships left to spray this spring; the State roads have been sprayed by truck and will soon be spot sprayed using ATV equipment; County road spraying will begin in the near future; approximately 1,200 miles of road have been sprayed to date; 25 acres of private property have been sprayed along with some roads within the Watertown City limits; and calls on Leafy Spurge control have been coming into the Weed Office.

WEED MANAGER RESIGNATION

Weed Dept. Manager, Paul Johnson, submitted his resignation to the Board effective June 30, 2014. Chairman Brinkman accepted Paul's resignation on behalf of the Board with regrets and best wishes. The Board thanked Paul for his three years of service to the Codington County Weed Office.

Motion by McElhany, second by Hanten, to approve the compensation scale as presented by the Human Resource Officer and to place Weed Supervisor, Steve Molengraaf, at step 8, effective July 1, 2014; all presented aye; motion carried.

COURTHOUSE BANNERS

Veteran Service Officer, Al Janzen, requested authorization to hang patriotic bunting/banners on the Courthouse in celebration of the week leading up to and including the Independence Day weekend. Motion by Hanten, second by McElhany to authorize the hanging of the banners as requested by Mr. Janzen; all present voted aye; motion carried.

REGIONAL AGING COUNCIL OF NORTHEAST SOUTH DAKOTA

Dr. Jim Seeber, Northern State University and Jeremy Herrboldt, Adult Senior Activities Coordinator with the City of Watertown, met with the Board to review the operations of the Regional Aging Council of Northeast South Dakota. Dr. Seeber requested that the Board consider appointing two persons, from Codington County, to sit on the regional council. The Board will collaborate with the City of Watertown to appoint two Board members, at a future meeting, and to also take action to set a per diem for said council members.

EXTENSION CENTER COMPLEX PARKING LOT

Watertown Mayor, Steve Thorson, met with the Board to request that the County consider budgeting funds in 2016 to share with the City of Watertown in the cost to resurface the parking lot on the south end of the Extension Center complex adjacent to the complex, softball fields and ice arena. The Board took this request under advisement. Mayor Thorson will contact the Auditor at a later date with an estimated cost of the proposed project.

TAX DEED PROPERTY TRANSFER

Treasurer, Carol Maloney, presented the Board with a proposal that would allow a property owner, whose property, record #10893, was taken by the County by tax deed proceedings, to rebuy the property with a payment of \$1,500.00 at this time and additional \$500.00 monthly payments until all costs and taxes, currently estimated at \$8,991.86, associated with the tax deed proceedings are paid to the County in full. The estimated time for the full rebuy would be fifteen months, more or less, based on any payments made above the required \$500.00 monthly payments and fluctuating monthly interest costs. Motion by Johnson, second by McElhany, to approve the proposal as outlined by the Treasurer to allow the property owner to retain their property; all present voted aye; motion carried.

WELFARE OFFICE PART TIME SUMMER CLERICAL

Motion by Johnson, second by Hanten, to authorize the hiring of a part time summer clerical employee in the Welfare Office. Commissioner McElhany suggested the use of an intern, currently working in another County office, for this position. Commissioner Johnson would like to leave that option up to the discretion of the Welfare Office based on the clerical tasks involved in that office. Upon vote of the Board; Heller, Johnson, Brinkman, and Hanten voted aye; McElhany voted no; motion carried.

BOY SCOUT TROOP 8

Auditor, Cindy Brugman, expressed her thanks to Boy Scout Troop 8 of Watertown and the following scouts for their assistance on the evening of June 3rd with the delivery of ballot boxes and election supplies to the County Auditor's Office: Ethan Maag, Nick Vockrodt, Tyler Mutzigel, Scott Johnson, and Bryson Vandepol.

AUTOMATIC BUDGET SUPPLEMENT

Motion by McElhany, second by Hanten, to approve an automatic budget supplement to the Emergency Management budget with Homeland Security grant funds reimbursement in the amount of \$8,000.00; all present voted aye; motion carried.

TRAVEL REQUESTS

Motion by McElhany, second by Hanten, to approve the following travel request; all present voted aye; motion carried: 4-H Youth Program Advisor; Jodi Loehrer; National Association of Extension 4-H Agents Conference in Minneapolis. Ms. Loehrer, current President of the South Dakota Association, noted part of the costs for her travel will be covered by the State of South Dakota.

AG. BUILDING RENTALS

The Board held a discussion regarding new clean up/disinfecting costs associated with livestock shows held at the Extension Center Complex. Discussion was also held regarding the County's policy of requiring a certificate of liability insurance, with coverage of up to \$1,000,000.00, for groups renting space at the Extension Center Complex. It was noted this coverage has previously been waived for some groups. A meeting of groups, associated with 4-H, along with Facility Manager, Milo Ford, has been scheduled at the Extension Center Complex to discuss these items before bringing anything to this Board for action.

JUSTICE CENTER BUILDING PROJECT

Discussion was held regarding exploring the design build concept in conjunction with the Justice Center Building Project. Commissioner Heller urged the Board to set aside significant funds during the budgeting process for the Justice Center Building Project as a contingency if the bond election would fail. Commissioner Heller also asked the Board to consider creating a position and budgeting funds for a Commission Administrative Assistant.
